 - B.) Trustee Training: Social and Charitable Gambling: The Library Board members read and reviewed information on raffle fund raising from the Dept. of Inspections and Appeals from the Law Library, Mandy Easter. The Iowa Code, Chapter 99B, "Social and Charitable Gambling" governs such events: Section 99B.24 "Raffles",
 - Section 99B.1 (26) public library in our state are qualified organizations,
 - Section 99B.24 (3), says a qualified organization may conduct one very small raffle per year without a license.

- Section 99B.11 (5) defines "very small raffle" are a raffle where the cumulative value of cash prize or prizes is \$1000 or less, or cumulative value of the donated merchandise prize or prizes is \$5000 or less and value of all entries sold is \$5000 or less.

After reading and reviewing this, the Library Board members will discuss this more at our next Library Board meeting. Laura will do some more checking if we need a license and ideas for the raffle ticket price for the quilt raffle. We are still thinking of raffling off this quilt in December.
