- I. The Roland Library Board meeting was called to order at 7:07 pm. The following Board members were present: Darla Anderson, Shauna Anthony, Andy Oetker, Bruce Gauley, Joy Thye, and Library Director Laura Urbanek
- II. Limited Additions to Agenda: none
- III. Boardmember Introductions: Boardmembers introduced themselves to new member Darla Anderson.

- V. Approve minutes from January 10, 2019 meeting: The Roland Library Board minutes were read and reviewed. Shauna Anthony made the motion to approve the minutes and Joy Thye seconded it. Passed 5-0.

Items discussed included governance, financial matters and accounting practices. C.) Meeting with the Library Foundation Boardmembers Shauna Anthony and Joy Thye updated the board on their meeting with Foundation President Rick DeWald. Based on the fact that the Board of Trustees' mission for the library differs significantly from the Foundation's mission for the library, the members of the board feel that it would be more beneficial at this time to look at other avenues for handling the funds brought in by the new Friends of the Library group.
